- 2. We reiterate on our stand communicated vide one earlier letter No. 1170 dt. 09.04.2015 & 1266, dt. 23.04.2015.
- 3. The work of construction of PEB Godowns at Kanti 5000 MT, Kurhani 2x1000 MT., Gaighat 2x1000 MT. in Muzaffarpur District and at Vaishali 1000 MT, Lalganj 1000 MT., Patehi Belhar 1000 MT., Goraul 1000 MT. Premraj 500 MT., Mahua 1000 MT., Patepur 1000 MT., Hajipur 5000 MT. Desari 1000 MT, Sahadei Bujurg 1000 MT., Jandaha 1000 MT. in Vashali District was allotted vide Chief General Manager's Letter No. 730 (Anu) dt. 21.02.2015. Subsequently The Deputy General Manager, BSBCCL, PIU, Muzaffarpur issued letter of acceptance vide letter No. 200, dt. 26.02.2015 asking you for depositing Balance Initial security Deposit & executing agreement prior to take up the work at the earliest.
- 4. It had been requested by you vide letter under reference to return the earnest money deposit or to award the work at the quoted rate and not on schedule rate.
- 5. As such, the letter of allotment of the work in favour of Richa Industries Ltd. bearing No. 730 (Anu) dt. 21.02.2015 and subsequent your letter of acceptance issued by Deputy General Manager, BSBCCL, PIU, Muzaffarpur bearing No. 200 dt. 26.02.2015 are here by withdrawn, The work is now being retendered and due to your this indisciplined act, you are henceforth being declared unfit to participate in any tender of Bihar State Building Construction Corporation Ltd.
