The bidder shall furnish a currently issued (in original, after the date of issuing this tender) notarized affidavit of non-blacklisting (by any Govt. / Private institution) certificate containing a declaration to the effect of non-pendency of vigilance/CBI/CID/Police case against it (firm/owner).
